LONG TERMS & CONDITIONS

- 1. These Terms and Conditions ("T&Cs") prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry instructions are deemed to form part of the T&Cs and by entering this promotion to receive a personalised letter from Santa ("The Promotion"), all participants will be deemed to have accepted and be bound by these T&Cs. FREQUENTLY ASKED QUESTIONS



GENERAL QUERIES

1. What is the promotion for and how long does it last?

This promotion allows you to claim a personalised letter from Santa ("Letter from Santa"). The promotion starts on 1 November 2020 and all applications must be received on or before 6 December 2020.

2. How old do I need to be to enter?

This promotion is only open to people aged 6 years or older. Any entries made by minors must be accompanied by parental or guardian consent. By participating in the promotion, you warrant that the intended recipient of a Letter from Santa is at least 6 years old and will ensure that express permission of the recipient's parent or guardian has been obtained.

3. Can I participate if I am not a resident?

Unfortunately, only residents of either the United Kingdom or the Republic of Ireland are eligible to participate in this promotion.

4. How many times can lenter this promotion?

There is no limit on the number of times you can enter. However, each time you choose to enter, you must supply a new, completed letter to Santa (cut out from the back of a Corn Flakes promotional pack). Each letter template is only valid for one entry.

5. Do I need to purchase a pack to enter?
